## **Rules and Regulation**

Bordetella Vaccination Required every 6 Month - NO EXCEPTIONS

We accept dogs at 3 months old, if they have had their 2<sup>nd</sup> set of puppy shots. Rabies Vaccination is required by 6 months of age. By signing below, you acknowledge the risk of enrolling your dog into daycare or boarding before they are fulling vaccinated

All dogs must be fixed (spayed or neutered) by 1 year of age. If undesirable traits such as excessive mounting, aggression and heat arise your dog will not be allowed to participate in daycare until they have been fixed. Mt. Hood Pet Resort will not be held responsible for any accidental pregnancy's that may happen from your pet entering daycare or boarding before they are fixed. Female dogs <u>cannot</u> attend our Doggie day care if they are coming into their heat cycle, during their cycle or the week after their cycle has ended. **No exceptions.** 

We recommend that all dogs be on Flea and Tick Program. Should we see any signs of Fleas we will give your dog a flea bath at an extra charge of \$ 35.00 and up. No Exceptions.

We recommend that all dogs will have a collar with a legible I.D tag. Quick release collars are best. For safety reasons choke chains, gentle leaders, prong collars and leather collars are not permitted in the daycare area.

All dogs must be current on vaccinations (DDHP, BORDETELLA, and RABIES) and copy of Vaccinations on file at MT Hood Pet Resort LLC with a completed application. Home vaccinations accepted with vaccination labels, receipts and dated.

All dogs must display health and temperament characteristic that are conducive to a fun and safe environment.

We reserve the right to use Bark Collars on your pet. We will try every means to get your pet to stop their excess barking while in the kennels. Such as squirting with water, putting a blanket in front of their kennel door, or asking them to stop barking. Prior to putting on a bark collar. The collars are not on your pet while they are playing in the Daycare Park. We use the collars as a training devise only.

All breed dogs over the age of 1 year will go through an initial behavior assessment to determine enrollment eligibility, prior to admittance in the daycare. Reservation required. Cost is \$35.00 for 3 (Three) hours.

We ask that you reframe from bringing your dog to MT Hood Pet Resort LLC if he/she shows any signs of illness (vomiting, diarrhea, coughing, etc) to prevent contagious sickness or diseases and that you let us know.

All dogs must be picked up during posted business hours. Late pickups are assessed extra

fees of \$5.00 for every 5 minutes. No exceptions. Boarding dogs are to be picked up by 10:00 am otherwise you will be charged \$5.00 per 1/2 hour until 12:00pm at which time, we will charge full day fee for their stay. In the event of an emergency and your dog requires veterinary care, we will make every attempt to reach you or your emergency contact by phone. If we cannot reach you, your dog will be taken to one of the Sandy's veterinary clinics. If the veterinary clinics are closed then we will take them to Northwest Vet Specialist in Clackamas, OR.
